SECTION 7. Handling and storage

Precautions for safe handling:

Provide good ventilation. Prevent electrostatic charge - sources of ignition should be kept well clear - fire extinguishers should be kept handy. Avoid contact with skin and eyes. Avoid prolonged exposure. Wear appropriate personal protective equipment. Observe good industrial hygiene practices. When using, do not eat, drink or smoke. Wash hands thoroughly after handling.

Conditions for safe storage, including any incompatibilities:

Store in tightly closed original container in a dry, cool and well-ventilated place.

Container is not designed to contain pressure. Do not use pressure to empty container or it may rupture with explosive force.
